Animal Health Division:

Action Item #1 Proposed ARM amendment re: Deputy Veterinarians, Dr Tahnee Szymanski

- Updating 2010 brucellosis and animal health rules to be consistent with new federal definitions

Brett DeBruycker moved to authorize publication of changes as presented. Jeff Lewis seconded. The motion carried unanimously

- Current revenue is approximately \$15,000 cost for forms, and tags.purpose is to recoup costs presently coming out of per capita funds for specialized services and items over and above what is currently charged

The board tabled the item until Tuesday to allow time for further study.

Action Item #3 Proposed ARM amendments for Domestic Bison, Dr Szymanski

Action Item #4 CAN Branded Cattle into Montana

- Montana requires hot iron CAN branding as of 2008 by official order on Canadian cattle imported into Montana
 - Animal Health recently received a request to import a Canadian bull to be allowed to enter Montana for show only with only the tattoo, not hot iron branded.
 - the bull was born in the US and went to Canada, owners not want to show and breed the bull in the US under an exemption to the hot iron brand
 - second issue is the question should the hot iron policy continue since there have been no BSE cases in Canada recently

The board declined action on the issue. Dr Zaluski is charged with reply to the request.

- AAVLD Accreditation
 - retaining provisional accreditation continue to February 2014
 - four corrective actions requested (no major issues)
 - then we will either be granted accreditation from one to three years, or
 - lose our accreditation and can either reapply or look for accreditation elsewhere
- Incinerator issues
 - losing chunks off the refractor
 - received quote from the manufacturer, came in and fixed it

 - will be getting a maintenance contract
 - quote for repairs was \$10,000

- a variety of housekeeping changes in wording and moving fees from subchapters to the fee section in chapter 2, removal of cites from within the rule

Ed Waldner moved to authorize publication of proposed changes as presented. John Lehfeldt seconded. The motion carried.

- PRCA exception request regarding steer branding
 - Mike Gallagher called in to explain how PRCA protocol conflicts with present brand laws
 - could allow exemption with conditions

The board charged John Grainger to move forward with drafting an ARM addressing this issue.

- Brand requests:
 - brand owner request to remove a scatter brand

Board consensus was they cannot make an exception when other requests have been refused.

- Request from Danielle Stieglmier to obtain a Montana brand that coincides with her South Dakota and Wyoming brands
 - the requested brand is no longer issued per protocol
 - purchasing a Wyoming ranch and branded cattle, ranch owner does not want to sell the brand
 - they do currently own a Montana brand

Board deferred the request to the January meeting as an action item.

- Action Item #7 District boundary realignment
 - proposed making minor boundary changes to make them more equitable

John Lehfeldt moved to authorize changes as presented. Linda Nielsen seconded. The motion carried.

- Pay Analysis
 - still a work in progress
 - surveyed all western brands states
 - Montana is second lowest in starting wage for market inspectors and the lightest staffed
 - Nevada has four inspectors for two markets working approximately 63,000 head
 - California has 29 markets handling two million head with each inspector responsible for inspecting 73,000 head
 - the issue is not just starting wage but more with filling upper level positions
 - experienced staff not wanting to move into market supervisor position citing dependency on spouse 's income, can't afford to move

- estimate it will take \$250,000 to get the entire brand division up to 2012 norm
- Mike Hayes request for waiver to reside outside his district
 - moved from Helena to take over District 5
 - cites lack of affordable homes within his district due to the oil boom
 - owns cabin just outside Essex and has been living there
 - provided data to show that 80% of his calls are in Glacier and Pondera Counties
 - Liberty County sheriff does all the cattle in his area
 - could park the department truck in East Glacier to avoid fuel issues
 - John Grainger stated Mike is the most qualified person for this district due to his complete familiarity with the area

John Lehfeldt moved to grant a variance in housing as present with a reevaluation in six months. Linda seconded. The motion carried.

Meat Inspection, Gary Hamel

- completed annual self-assessment
- federal auditors will be in Montana next May and June
 - first they do a walk-through of plants
 - then hit the books to assure we are in compliance
- hired three positions and now are fully staffed

Milk & Egg, Dan Turcotte

- as of yesterday back to full staff as Rosemary is back from surgery
- Montana Egg decided to go back to four days requiring a new contract
- filled new half time position who will be attending training in Washington in January
- raw milk incident in Yellowstone County
 - notified by county health department of a none month old with E. coli from raw milk
 - no milk sample or evidence
 - Mother said she had given the child raw milk then declined to name the dairy
 - appears to be a dairy the department sent three raw milk letters to
- raw milk issue in general
 - South Dakota just passed raw milk rules, this issue is not going away
 - need to look at drafting raw milk rules for Montana to forestall action in the next legislature
