Per Administrative Rules of Montana:

#### 32.15.104 CHANGES IN OPERATION OF MARKET

- (1) The owner of a licensed livestock market must immediately notify the department of livestock of any changes in ownership, management, control, operation, the regular sale day or location of the market. All changes are subject to the prior approval of the department of livestock.
- (2) Changes which result in ownership or control of the market passing to persons not already approved by the department of livestock to operate the market may be given approval only after public hearing before the department of livestock.

(3) All other changes may be approved without a public hearing, provided that whenever the board of livestock deems it in the interest of the livestock industry, the board may order a public hearing to be held.

The Board has asked for input from interested parties to assist them in determining whether or not to grant this request. The Board will hold a conference call on September 12<sup>th</sup>, 2017, to discuss this request and any comments that are received. Due to the often slow rate of mail delivery, I would recommend that you either email your comments or plan to call into the conference call to ensure that the Board receives your input.

# Montana Board of Livestock **Petition for Sale Day Change**

For over 50 years, Billings Livestock Commission sale days have been Monday and Thursday. At the same time, Public Auction Yards sale days have been on Wednesday and Friday. The Monday and Wednesday sale days would not change.

We are requesting to move BLS from Thursday to Friday and PAYS from Friday to Thursday. The Wednesday and Friday sales would be feeder cattle specials and run from October through February, and some select specials throughout the year. The Monday and Thursday sales will be all class cattle sales and run throughout the year.

We feel this is beneficial for several reasons:

- We can utilize our shared work force more efficiently and reduce long, late night hours in the busy season.
- By steering consignments to select sales, we will spread numbers out over the week. This will reduce stress on the livestock and personnel and make for a more efficiently run sale.
- Our consignors will have a better opportunity to select their sale days for the class of cattle they are marketing without limiting the convenience factor.
- We also think this will be beneficial to the Brand Department by reducing the late hours on sale days.

We run two successful markets in Billings and serve farmers, ranchers, and Buyers. They cover a wide area in Montana and Northern Wyoming. We are moving into the third family generation of operation and plan to be here for many years to come. We have always had a good working relationship with the Board of Livestock and their personnel and will continue to do so.

We respectfully request that these changes be approved.

Thank you for taking time to look at this proposed schedule change.

As we all know, change is hard for most people. However, we feel this a very positive change for all involved. While there are many reasons as to why this change is good, we would like to focus on three very important reasons.

- 1. This is a positive change for the producers who utilize the competitive markets of Billings. We will be able to sell like classes of cattle on a certain day allowing us to attract more buyers who buy only certain classes of cattle. (Example: Feeder only sales, featured weigh up sales, & stock cow sales.) We will be able to do more pre-sorting which will be better for the welfare of the cattle and also will allow us to do the best job possible in marketing the cattle. By having these particular days we will not limit the convenience factor that producers have always liked about Billings.
- 2. This change will allow us to be able to spread our numbers out over the week by directing certain cattle to certain sales. This is the main, and most necessary, reason we have proposed this change. By spreading our numbers out over the course of the week, we hope to limit our extremely long sale days. This will be a huge benefit to our employees, the Brand Department and the Vet crew. Like all businesses and State agencies, finding and keeping good employees is our biggest challenge. We strongly feel that the changes we can make to make it better for our employees, the Brand Department and the Vet crew **need to be made**. In 2016, the two Billings markets ran 252,009 head of cattle, 63,638 head of sheep, and 6,777 head of horses. These sales generated nearly \$640,000 in inspection fees and provide good employment to over 70 full and part time employees. We fully recognize this change is necessary to continue this.
- 3. Lastly, this schedule change will benefit buyers and truckers that use the Billings markets. Buyers will be able to attend class specific sales (ex: feeder only sales, featured weigh up sales, & stock cow sales). In 2016, over 35% of our cattle numbers were weigh up cows and bulls and bred cattle. By getting these grouped a little more on their own day we will limit yard mistakes, be able to control the length of the sales, and be able to tell buyers what we have in the line-up ahead of the sale. When the buyers have a better idea what they may be able to purchase on a certain day, it will allow them to line up trucks. With buyers and truckers having a better idea of the numbers, types of cattle and days of cattle selling, it will make it more efficient in moving cattle out to their next destinations in a timely fashion.

We have contacted all of the auction markets in Montana and have explained that this change is for employee's convenience and cattle welfare. By no means is it to try and overshadow a sale day, or take buyers from another market. Also the two Billings markets have always had Monday, Wednesday, Thursday and Friday as sale days. We are not asking for new days, just wanting and needing to utilize our current days more efficiently. Billings Livestock has had a Monday sale since it started in 1934. The Department of Livestock granted Bozeman (now Headwaters) a day change from Friday to Monday around 1980.

In conclusion, we want to stress that we feel this a necessary change to continue the level of service and the volume of livestock that currently exists in Billings.
