#### **Personnel Issues**

Mike Honeycutt told the BOL he had called the conference call together to discuss the motion made by the BOL at the June 13, 2017 board meeting to do a reduction in force (RIF) in the Centralized Services Division (CSD) effective July 1, 2017:

- The RIF would do away with Mr. George Harris' position as Administrator of CSD
- In a June meeting with Mr. Harris, Mr. Honeycutt and legal counsel Rob Stutz, Mr. Harris indicated that he would prefer to pursue retirement as opposed to moving forward with RIF

- Mr. Harris submitted a retirement letter on June 16, 2017 to Mr. Honeycutt stating his retirement would be effective June 30, 2017
- Mr. Harris submitted a signed Release of Claim form on June 16, 2017, releasing the DOL of any future or further claims from him. He has until June 23, 2017 to revoke that claim
- The BOL agreed to pay Mr. Harris unused compensation time of approximately 100.5 hours at his current hourly wage of \$40.70/hr for a total of \$4090
- The BOL agreed to pay Mr. Harris a retirement payout of \$12,000
  - Loss of \$1628 of compensation in July until first retirement check arrives August 1, 2017; Loss of the retirement of \$7128, due to retiring in a month with two pay periods rather than three pay periods. Total request of \$8756 was increased to \$9000 by BOL
  - o A \$2500 gap in health insurance was increased to \$3000 by the BOL
