

John Sampsel requested approval of the LLB April 30, 2025 meeting minutes

Doreen Gillespie moved to approve the minutes from the Montana Livestock Loss Board April 30, 2025 meeting. Jordan Mannix seconded. The motion passed.

(2:54) 1:03 PM - CLAIMS AND BUDGET STATUS UPDATES

Brian Simonson reviewed the claims numbers, as of July 24, 2025, and the current budget status report:

- Mr. Simonson reported that the first Black Bear claim arrived in July, this one from Lewis & Clark County. He explained that the report form would be revised to include the recently added Black Bear and Bison
 - He added that there had been a total of 69 claims total made for year, totaling nearly \$108,000, which was comparable to spending in the past couple years
- The budget status report showed that the Personal Expenses had started out with \$100,000, with half of it spent when there was an employee in the Director position, then one-quarter of it was spent for his payout
- The Operations budget, Mr. Simonson said, started out at \$42,000 and \$33,000 of it had been spent. He said currently, the LLB office was being used as an

"expensive" storage facility for LLB items and that should be addressed in the future

- There was \$175,000 left in the claims money account
- Mr. Simonson explained that if \$95,103 was given to Wildlife Services this year, there would still be nearly \$400,000 available to go out in prevention dollars.
 There was also \$86,892 available in the LLB license plate donation fund, which had gained about \$7,000 to \$10,000 per year since it's inception

Brian Simonson requested action from the LLB on what amount of the LLB's Loss Reduction Funds they wanted to award to Wildlife Services this year:

Raina Blackman moved to award Wildlife Services with the Livestock Loss Board's Loss Reduction Funds of \$95,103, as presented by Brian Simonson. Doreen Gillespie seconded. The motion passed.

Dalin Tidwell updated the LLB on the latest activities for USDA Wildlife Services:

- Regarding Investigative Reports (IRs) from October 1, 2024 to current, Mr.
 Tidwell reported the following: Black Bears 15 IRs, with 13 confirmed; Grizzly Bear 89 IRs, 75 confirmed; Mountain Lion 16 IRs, 14 confirmed; Wolf 55 IRs, 44 confirmed
- Mr. Tidwell instructed the LLB on how to use Wildlife Services Form 37 to report migratory bird damage explaining the special measures to follow regarding Golden Eagles
- The last two months, Mr. Tidwell said, had been spent recruiting and hiring positions in Wildlife Services that had been recently lost due to the Deferred Resignation Program in the Federal Government
- The blades had been replaced, Mr. Tidwell reported, on the 95 Tango helicopter and they had been able to continue use of the ATOC spare helicopter that was brought in for use during that repair

Joe Kipp reported that much was being done for awareness of eagle depredations in Montana:

Mr. Kipp said that Northern Ag Network had put up a Facebook page that had
received a lot of comments from producers regarding eagle depredations. He
explained that the hope was to build up a database of producers who had eagle
depredations and hopefully move forward with it from there. He requested that
Dalin Tidwell submit a statement for Colter Brown of Northern Ag Network, to add
to their Facebook page regarding eagle depredations

 Dalin Tidwell said that USDA Wildlife Services would do investigations on possible eagle depredations with that Form 37, which went to US Fish and Wildlife and was used as part of the application for their depredation permit process

Lindsey Simon requested approval from the LLB to move forward with the rulemaking process on proposed language for an LLB Public Participation rule:

 Ms. Simon reminded the LLB that at their April meeting, they had elected to choose the same structure that the BOL had chosen for their Public Participation rule and so she brought language for the LLB to review for their own Public Participation rule, adding that if they approved it, she could move forward with the rulemaking process without having to come back before the Board

Brian Simonson reviewed the new job description written for the person that would be filling the vacant position in the LLB. He would need approval from the BOL to move forward with the hiring:

- Mr. Simonson explained that the new job description was written for the Helena Program Specialist 1 to work 20 to 30 hours per week, some of which might be utilized for "other duties, as assigned" in the DOL. Pay scale would be around \$28.85 to \$29.31 per hour
- Mike Honeycutt that this would be a DOL position, but the work they would do for the LLB, the policy and strategy direction and things they would need to work on would come from the LLB. During the LLB's slow time of year for claims, the intent was to keep their duties similar to predator control activity, such as possibly helping with the Aerial hunting program or with the grant program

 Mr. Simonson explained that the addition of those two animals had already been made in statute, but the LLB area of the website, including the Mission Statement and Objectives, should be changed as well to match those made in statute by the Legislature. The LLB agreed that Mr. Simonson could make those website changes without having to vote on it

 more efficient
